

AWARDS



Draw Eligibility:

1/20 (Saturday) Registered attendees of the year-end party and on-duty personnel on 1/20 (Saturday) (excluding those on on leave/consultants/dispatched).

Draw Guidelines:

- 1. All awards on the day of the year-end party will be drawn by computer.
- 2. The Chairman's Award/CEO Award/VP Award/CEO Award will be drawn during the evening party. The rest will be drawn starting at 10:00 AM on the day of the year-end party. The entire process will be recorded.
- 3. Winning messages will be sent out starting at 13:00 on the day of the year-end party. Colleagues can check the information on the official website as well. The redemption period is until 20:00 on the day of the year-end party. For updating personal mobile numbers, please go to the following link to update: Link
- 4. Colleagues must present their employee ID and the winning confirmation message in the SMS to sign and confirm at the redemption area. Failure to present identification or exceeding the redemption time will be considered a waiver (except for those on duty or official business on the same day). For T5 colleagues who take the shuttle bus, if T5 colleagues cannot complete the process due to the return shuttle bus, the actual return record will be used as proof of redemption.
- 5. All the unclaimed awards will be donated to charitable organizations collectively.
- 6. All cash awards will be distributed to the winning colleagues' salary accounts on 1/31 (Wednesday). Physical awards will be distributed in the week of 1/29.
- 7. Distribution conditions: Winning colleagues who are currently employed.
- 8. Year-end party draw awards will be recognized as personal income.
- 9. The cash or prize amount given to the winner in the year-end party draw activity is considered income under Article 14, Paragraph 1, Item 8 of the Income Tax Act. A 10% tax will be directly deducted for Taiwanese winners, and a 20% tax will be directly deducted for foreign winners when the award is credited.
